

**NOTICE INVITING APPLICATIONS FROM PRIVATE
HOSPITALS FOR EMPANELMENT
BHAJ GHANHJA SEHAT SEWA SCHEME-2017**

The Bhai Ghanhya Trust (Under the Chairmanship of the Hon'ble Chief Minister, Punjab) has taken initiative to provide quality health care services to the members and employees (including retired employee) of the Eligible Cooperative Societies, employees (including those who have served the Department at any point of time or retired employees) of Department of Cooperation, Punjab and Bhai Ghanhya Trust and their families across the State of Punjab and Chandigarh, at affordable price.

SALIENT FEATURES OF SCHEME

- Covers treatment of all medical/surgical diseases requiring minimum 24 hrs. Hospitalization along with few other listed diseases which do not require 24 hrs or more hospitalization, up to a maximum expenditure of Rs. 1.5 lac per year per beneficiary/family on floater basis.
- Hospitalization shall be allowed exclusively in network hospitals empanelled under The Bhai Ghanhya Sehat Sewa Scheme on cashless basis and Govt. Hospitals on reimbursement basis.

ELIGIBILITY

Hospitals eligible to apply should meet the following criteria:-

- Having at least 15 bed indoor treatment capacity and fully equipped Operation Theatre and ICU.
- Having at least 2 permanent doctors (M.B.B.S, M.D or D.M) on its rolls and atleast one postgraduate doctor available either on permanent basis or panel basis. The hospital should also have at least one DM Doctor for the super specialty catered to by the hospital.
- Having the facility of atleast three permanent trained nurses (who are registered with nursing council of India) and medical staff round the clock.
- Having facility of in house pharmacy and pathological lab or tie up for pathological tests/pharmacy to ensure completely cashless treatment to Beneficiaries.
- Having established or willingness to establish necessary hardware and softwares for e-preauthorization and transfer of radiological images.

HOW TO APPLY

The Empanelment Forms downloaded from the mentioned urls should be accompanied with a Demand Draft for an amount of Rs 10000/- in favor of "The Bhai Ghanhya Trust" payable at Chandigarh towards the cost of Empanelment Form at the time of submission of duly filled Empanelment Form to the **office of Bhai Ghanhya Trust, SCO No 175-187 Sector 34 A Chandigarh Phone No: 0172-5014900.** The Empanelment Form along with Bank Draft for the said amount should reach the Trust office by 10.11.2016 positively. The said

amount shall not be refunded under any circumstances. All the Applicants shall be subject to the in house inspection by the Empanelment Team of the TPA/ Insurer, which shall decide upon the categorization of the hospital. The hospitals shall be categorized into two grades 'A' & 'B' based on the objective parameters as defined under the Scheme. The decision of the Bhai Ghanhya Trust in respect of categorization and empanelment of the hospital shall be final and binding upon all the parties.
